

MOAT - VanEck Morningstar US Sustainable Wide Moat UCITS ETF

VanEck Morningstar US Sustainable Wide Moat UCITS ETF seeks to track, before fees and expenses, the price and yield performance of the Morningstar® US Sustainability Moat Focus IndexSM. The index is a rules-based index intended to offer exposure to attractively priced U.S. companies with long-term competitive advantages, according to Morningstar, that have been screened for ESG risks. The index has a staggered rebalance in which it is divided into two subportfolios, each with 40 stocks. One sub-portfolio reconstitutes in June and the other in December. The information here pertains only to the sub-portfolio being reconstituted.
