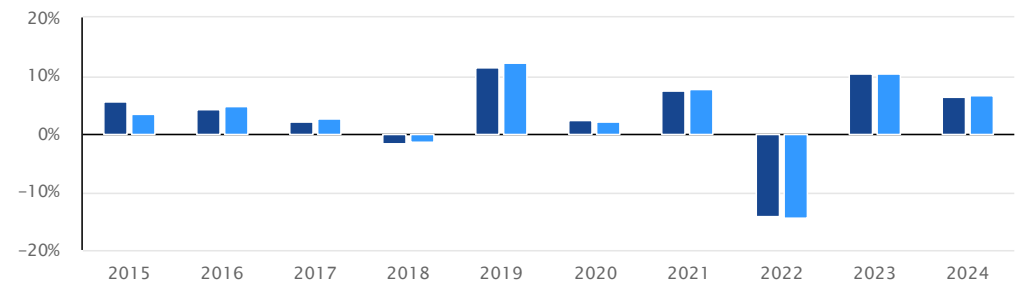
Fund Description
