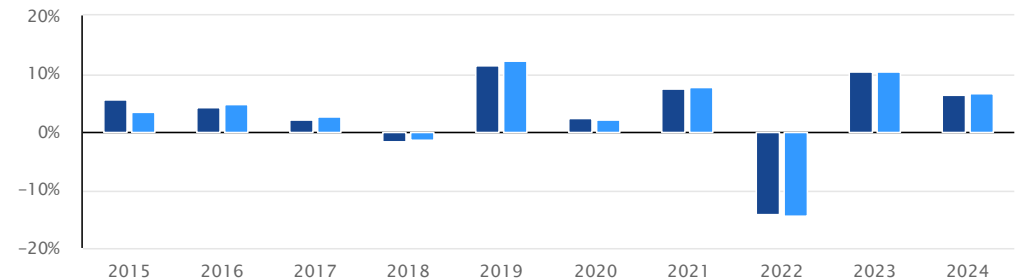
## Fund Description
