
Gaining an Edge from Social Sentiment

What people are saying about stocks matters more than ever before. Investors are increasingly gathering online to collaborate, discuss and identify investment ideas. The millions of daily interactions across on these online communities are rich with valuable data and insights about the potential future prospects of different stocks.

The BUZZ Index cuts through the noise, distilling these interactions to identify stocks poised for strong potential growth. This has been a winning strategy in both short and longer time periods based on batting average, which measures the percent of time a strategy outperforms the market.

VanEck Social Sentiment ETF (BUZZ) seeks to track as closely as possible, before fees and expenses, the price and yield performance of the BUZZ NextGen AI US Sentiment Leaders Index (BUZZTR), which is intended to track the performance of the 75 large cap U.S. stocks which exhibit the highest degree of positive investor sentiment and bullish perception based on content aggregated from online sources including social media, news articles, blog posts and other alternative datasets.
